Hold Harmless Agreement

The undersigned hereby releases and agrees to indemnify and hold harmless the town of Sewanee, the Sewanee Fourth of July Committee, and any members, agents, or volunteers of said Committee, for any and all liability for damages or injuries to persons or property which the undersigned, his or her agents or his or her employees may sustain while participating in the Street Dance, the Sewanee Fourth of July, or any events leading up to said events. Such indemnification shall include court costs and reasonable attorney's fees and costs.

I understand that the Sewanee Fourth of July Committee reserves the rights to refuse participation in this year or future years to any vendor who, in the Committee's sole and absolute discretion, does not meet the requirements listed above.

I consent to photographic and/or video recording of my image, vendor stand, products, and/or promotional material whether or not provided by me, and grant the Sewanee Fourth of July Committee and its members, agents, and volunteers the right to modify, copy, adapt, reproduce, distribute, and use photographic and/or video images for any promotional materials for this and future years.

I further agree that I am solely responsible for and will comply with Tennessee Department of Revenue rules for the collection and reporting of Tennessee State Sales Tax on sales in my booth and will follow all state and local laws (including state regulations on handling food products) in my designated area.

I have read and agree to all regulations above. In consideration of applying for food vendor space, the Sewanee Fourth of July Committee and I agree to be contractually bound to the terms herein. I understand that if litigation is necessary to enforce the terms of this contract that the Sewanee Fourth of July Committee shall be entitled to recover from me its reasonable attorney fees and court/litigation costs.
